

Terms of your Proposal

1. **PAYMENT BEFORE COVER WARRANTY** - Please note that the total premium must be paid and actually received in full by the Company (or the intermediary through whom this coverage was effected) on or before the inception date of the coverage, failing which the coverage/policy shall be deemed to be automatically cancelled and no benefits whatsoever shall be payable by Liberty Insurance Pte Ltd ("**Liberty**").
2. **PERSONAL DATA** - I give consent to Liberty and third-parties including related companies, employees, agents, brokers, service-providers, collaborators, partners, contractors etc. (collectively, "**appointees**"), and their appointees in turn, to collect, use and disclose all personal data whatsoever about myself, from any source, whether they were, are and/or will be collected howsoever by Liberty and/or the appointees in the past, present and/or future, for one or more of the purposes described in Liberty's Data Protection Policy as it may be amended from time to time, including but not limited to considering whether to provide insurance, due diligence, pricing, underwriting, administering and servicing my policies, communicating with me, renewals, reinsurance, collections, claims, accounting, audit, legal, compliance, research, analysis, surveys, dispute resolution, technology management, and anything incidental, ancillary, exploratory or supportive of the foregoing.
