

Opt-in Consent for Marketing, Sales, Advertising & Promotions

1. I hereby give consent to Liberty Insurance Pte Ltd (“**Liberty**”) and third-parties including related/associated companies, employees, agents, brokers, service-providers, collaborators, partners, contractors etc. (collectively, “**Appointees**”), and all of their downstream Appointees in turn, to collect, use and disclose all personal data whatsoever about myself, from any source, for the purposes of marketing, selling, advertising and promoting goods and/or services, including insurance and financial products & services (whether supplied by Liberty or otherwise), by any method including:
 - (i) post;
 - (ii) email;
 - (iii) voice/telephone calls to all telephone numbers of which I am the subscriber or user;
 - (iv) short-message service (SMS), multimedia messaging service (MMS), texting, to all telephone numbers of which I am the subscriber or user;
 - (v) digital media; and
 - (vi) visits and/or fax to all telephone numbers of which I am the subscriber or user,

and whether such data whatsoever (including all telephone numbers) were, are and/or will be collected howsoever by Liberty and/or the appointees in the past, present and/or future.

2. I hereby give a continuing warranty that I am the subscriber or user of the telephone numbers that were furnished in the past and present, and/or will be furnishing in the future, to Liberty and/or the Appointees, and all of their downstream Appointees in turn, from any source.
3. All personal data are accurate and complete, and I will inform Liberty of any changes to the personal data to my knowledge, or any changes to my status as subscriber or user of the telephone numbers, as soon as practicable.
4. If there is any personal data about or belonging to other individuals, I warrant that I have obtained prior consent from them (or if they are lacking in legal capacity, from their legal representatives, guardians or parents as the case may be) for Liberty and/or the appointees to collect, use and disclose their personal data for the purposes and on the terms stated in this document, as if they were me.

Notwithstanding anything to the contrary, I undertake to indemnify and at all times hereafter to keep Liberty and the Appointees, and all of their downstream Appointees in turn (and together with each of their respective officers, directors, managers, employees and agents) (each an “Injured Party”) indemnified against any and all losses, damages, actions, proceedings, costs, claims, demands, liabilities (including full legal costs on a solicitor and own client basis) which may be suffered or incurred by the Injured Party or asserted against the Injured Party by any person or entity (including such entity’s officers, employees, agents) whatsoever, in respect of any matter or event whatsoever arising out of, in the course of, by reason of or in respect of:
 - 6.1 any breach of any of the terms in this agreement; and/or
 - 6.2 any action or omission by me and/or any of my employees, contractors, subcontractors or agents, that causes Liberty and/or an Injured Party to be in breach of Singapore’s Personal Data Protection Act 2012 and its Regulations thereunder, as it may be amended from time to time.
7. Any Appointee, and any of their downstream Appointees in turn, and any Injured Party, may benefit from and enforce any term of this agreement, on its own.
